






# China's imports of *hongmu* logs and sawnwood, January 2014 – August 2017









# China's imports of *hongmu* sawnwood January – August 2017






#### China's imports of *hongmu* logs and sawnwood from West Africa January 2014 – August 2017

## CITES Enforcement: China

### **Progress:**

- CITES MA response enforcement is underway (awarenessraising, collaboration with enforcement)
- CAF Wood Research Institute report commissioned by Customs; collaboration with SAQSIQ)
- Wood ID and quarantine lab established in Zhangjiagang

## **Challenges:**

- Traders slow to react (speculation?)
- Shipments without permits
- Mislabeling
- · Capacity of enforcement officials
- Wood ID capacity other Customs districts?
- Time lag shipments sent prior to listings taking effect
  - Seizure in Huangpu (Nigerian logs)

# Vietnam's import classification system: 8 groups


#### Highest-value species include:

Classification	Species		
Group 1 (41 species)	Dalbergia oliveri, bariensis, dongnaiensis, tonkinensis, cochinchinensis, nigra, cambodiana, fusca Pterocarpus pedatus, cambodianus, indicus, macrocarpus Diospyros spp. Sindora spp.		
Group 2 (27 species)	Xylia spp. Dipterocarpus spp. Hopea spp.		




- China: One classification for 33 species
- Vietnam: Hundreds of species classified into 8 groups; no official government designation for rosewood, but Groups 1-2 contain highest-value precious wood species

# Vietnam's log and sawnwood imports from Laos, 2015 – June 2017




# Vietnam's log and sawnwood imports from Cambodia, 2015 – June 2017

## CITES Enforcement: Vietnam


## Progress:

- Listings largely being enforced, in keeping with government/industry developments to exclude illegal timber
- VPA negotiations concluded: import control mechanism; FLEGT and CITES staff sharing offices
- Timber associations' statement on excluding high-risk wood

### Challenges:

- Time lag shipments sent prior to listings taking effect
  Hai Phong seizure
- Costs to traders
  - Permit purchases
- Most higher-value species exported to China
